**STALLION SERVICE CONTRACT**

I hereby agree to breed a mare by the name of \_\_\_\_\_

\$ 250 of which is payable with this contract, and \$ 500 plus boarding fees will be

paid before the mare leaves the premises of Stallion Owner and before the foal can be registered.

It is further agreed that:

1. Upon demand of Stallion Owner, Mare owner will submit a certificate executed by a certified veterinarian indicating that said mare shall be in good health, has a negative vaginal culture and Coggins and is in breeding condition as of the time said mare shall be delivered for servicing, such certificate to be executed not more than five days prior to the date upon which said mare shall be delivered.
2. Should the above stallion die or become unfit for service, or if the above mare should die or become unfit to breed, then this contract will become null and void.
3. It is understood that Farm will not be responsible for accident, sickness or death to my mare (or foal), and that you will exercise your judgement in caring for and supervising my mare (and foal).
4. Should conception not result said mare may return during the season of 20\_\_\_\_, only. (Unless otherwise agreed by Stallion owner).
5. Should conception still not result after the time stated in paragraph 4

above, by effort on Stallion Owner's part, or should said mare prove to be barren as evidenced by a certificate of a qualified veterinarian, Stallion Owner will have earned the entire stud fee.

6. In case of an emergency or for proper treatment and protection of said mare (or foal), Stallion Owner may call on the services of a veterinarian without first obtaining such consent of the Mare Owner and at the Mare Owner's cost and expense.

7. Board for Mares:

Stable Board ..... \$ 25.00 \_\_\_\_\_, per day.

All boarding fees and other costs must be paid before the mare leaves the farm.

8. Should Mare Owner fail to deliver said mare on or before \_\_\_\_\_, 20\_\_\_\_, to the premises where said stallion is standing for the purpose of breeding said mare, the Stallion Owner shall be under no further obligation under this contract.

9. This contract shall not be assigned or transferred by the Mare Owner.

10. This contract is not valid unless completed in full.
